In exchange for permitting the Participant to participate in the activities, to the extent permitted by law, I/we agree to waive all claims for damages, expenses, and costs that I/we may have, or which may subsequently accrue to me/us or the Participant against SSI, it's employees, officers, agents, representatives, and assigns for death, personal injuries, and losses to property, real or personal, caused by or arising out of the SSI programs and/or activities resulting from an inherent risk in the programs and/or activities. I/We also agree to any of the SSI staff, employees, agents, or representatives administering, or consenting to the administration, of any and all necessary medical services to the Participant under the general or special supervision and upon the advice of a physician or surgeon licensed under Florida law. I/We hereby authorize medical treatment in case of emergency. I/We understand and acknowledge that SSI does not carry or maintain health, medical, or disability coverage for the Participant and therefore agree to assume the responsibility for the cost of any such emergency medical care and warrant that I/we carry such insurance coverage for and on behalf of the Participant. I/We further agree to provide SSI with a copy of medical insurance card for the Participant (in the event of emergency), current information concerning the Participant's medical or physical conditions, including, but not limited to, any allergies the Participant may have, medications the Participant takes, and whether the Participant suffers from asthma.
